

2) For the telephone number(s) specified herein, this authority includes the authority to record and decode all post-cut-through digits, as described in the Government's Verified Memorandum of Law Regarding the Collection of Post-Cut-Through Digits Through Telephone Pen Register Surveillance Under the Foreign Intelligence Surveillance Act, filed with the Court on  in (S) (S) Docket Number  The Government shall not make any affirmative investigative use, through pen register authorization, of post-cut-through digits that do not constitute call dialing, routing, addressing or signaling information, unless separately authorized by this Court.

(a) Furnish the FBI with any information, facilities, or technical assistance necessary to accomplish the installation and operation of the pen register and trap and trace device(s) in such a manner as will protect their secrecy and produce a minimum amount of interference with the services such person is providing. The specified person shall not disclose the existence of the investigation, or of the pen register or trap and trace device(s) to any person unless or until ordered by the Court, and shall maintain all records concerning the pen register and trap and trace device(s), or the aid furnished to the FBI, under the security procedures approved by the Attorney General and the Director of Central Intelligence (or Director of National Intelligence) that have previously been or will be furnished to the specified person and are on file with this Court. The FBI shall compensate the specified person(s) referred to above for reasonable expenses incurred in providing such assistance in connection with the installation and use of the pen register and trap and trace device(s) authorized herein;

- the length of the provision of service by such provider to the customer or subscriber and the types of services utilized by the customer or subscriber;
- in the case of a provider of local or long distance telephone service, any local or long distance telephone records of the customer or subscriber;
- if applicable, any records reflecting period of usage (or sessions) by the customer or subscriber; and
- any mechanisms and sources of payment for such service,

including the number of any credit card or bank account  
utilized for payment for such service; and  
if available, with respect to any customer or subscriber of incoming  
or outgoing communications to or from the service covered by the

number or identifier, of such customer or subscriber,  
including any temporarily assigned network address or  
associated routing or transmission information; and
- the length of the provision of service by such provider to
